Outcome of the meeting:

1. Sh. R.K. Gupta, President ISRMTT welcomed all the members present in the meeting.
2. The Minutes of $57^{\text {th }}$ meeting, of the Executive Committee of ISRMTT held on 28.12.2016 at CSMRS were confirmed.
3. Selection of Honorary Secretary

Sh. Amit Gupta, member was unanimously elected as the Honorary Secretary of ISRMTT for the period 2017-19.
4. Filling up of the post of Treasurer and Institutional members

Since, no nominations were received for the posts of Treasurer, Institutional members, Executive Body unanimously elected WAPCOS Ltd. and SJNL Ltd. as the institutional members of ISRMTT Executive Body for 2017-19. CMD, WAPCOS Ltd. and CMD, SJVN Ltd. shall be requested for nominations for representing these organisations. 5. INDOROCK-2017, $7^{\text {th }}$ Indian Rock conference to commemorate Silver Jubilee celebrations of ISRMTT.

The Executive Committee was informed that ISRMTT has completed 25 years on $4^{\text {th }}$ May 2017, since its inception in 1992. To commemorate the Silver Jubilee of ISRMTT, INDOROCK-2017: $7^{\text {th }}$ Indian Rock conference is being organized in Hotel Radisson Blu, Sector, 13, Dwarka, New Delhi. Sh. Hari Dev, Organising Secretary informed that

67 Abstracts were received. Apart from technical papers, 10 keynotes by eminent personalities are also planned to be included in the conference. It was also informed that about 15 papers have already been received. The Registration fee for the conference is Rs.10,000/- for Non- Members, Rs.8,000/- for members of ISRMTT/ authors of the technical papers and Rs. 4000/- for students.
